About the Presenter



Cory Jewell Jensen, M.S. Currently the senior trainer for CBI Consulting, recently retired from her position as Co-Director of the Center for Behavioral Intervention where she worked with adult sex offenders and their families for 34 years. In addition to her clinical work, Ms. Jensen provides training and/or consultation to The National Center for the Prosecution of Child Abuse, The National Child Advocacy Center, United States Navy, The National Crime Victims Association, The Mark Mc Gwire Foundation for Children, US Marshall's Office, NYPD Special Victims Unit and a number of law enforcement, child advocacy and Faith based organizations.

Ms. Jensen served as Executive Director for the Association for the Treatment of Sexual Abusers, chaired two of ATSA's International Research and Treatment Conferences and served as President of Oregon's Chapter of ATSA. She also chaired the Offender Management Committee attached to the Oregon Attorney General's Sexual Assault Task Force, has been an instructor for Portland State University's Child Welfare Training Institute for the past 15 years and has also provided training for Oregon's police academy.

Ms. Jensen has been the recipient of Oregon's "Commercial Crime Prevention Award," the "Champions for Children Award,"the OATSA "Significant Achievement Award," the Nunnenkamp "Award of Excellence," and the Jan Hindman Memorial Award. She has published a number of articles related to sex offender treatment, risk management and child abuse prevention, testified as an expert witness in local and federal courts and been a featured guest on radio talk shows and the Oprah Winfrey Show.

Conference Overview

Research indicates that one in four girls and one in seven boys will be sexually abused. The offenders will be someone close, a relative, family friend, or one of the many volunteers or professionals who come in contact with our children every day, someone most parents would never suspect. By taking the time to learn more about child sexual abuse and the people who commit these crimes, you will be joining a growing number of individuals who are becoming better educated about protecting children and safeguarding our communities. Remember: the responsibility for protecting children rests primarily with adults, not children alone. This presentation will briefly examine some of the factors that make children, churches, youth serving organizations, and schools vulnerable to sex offenders. The need for ongoing education about offender behavior and enhancement of practical prevention rules will be covered.
